ANNUAL REPORT TO THE WATCH HILL FIRE DISTRICT

I would like to thank you for the opportunity to address you today as Deputy Chief of the Watch Hill Fire Department. The last year has been one of tremendous transition as the Department has for the first in its over one hundred year history hired its first full-time career Chief of Department. Additionally, the Department was able to hire a new full-time Fire Marshal responsible for code enforcement, fire prevention and community fire education.

CHIEF OF DEPARTMENT

At the recommendation of a consulting firm hired by the District and after an extensive and far-reaching hiring process the Watch Hill Fire Department hired the first full-time Chief in its 120-year history. Chief Dennis Reall Jr. comes to us as a well-respected and experienced retired member of the North Providence Fire Department where he served as a career firefighter for 32 years. Upon his retirement in 2018 Dennis was hired as Watch Hill's second paid firefighter where he served until his recent promotion to Chief. Dennis has a passion and understanding of the modern fire service as a well as an appreciation of the long-honored tradition of volunteerism which has served the Watch Hill community for over a century. As we as a Department embark on this transition we are truly blessed to have found Dennis to lead us forward. We would like to welcome him, his wife Tracy and daughter Gemma to our community and wish him years of success

FIRE MARSHAL

In addition Christopher Moore was hired as Fire Marshal. Chris comes to us after serving nearly 16 years as Senior Fire Safety Inspector for the State of Rhode Island Fire Marshal. Chris's primary duties include code enforcement, plan review and event safety. Chris' ability to help business owners and residents "navigate" the sometimes confusing aspects of the fire code in a friendly manner has been warmly received. Chris has very quickly earned the respect and admiration of fellow members and we look forward to working with him for many years to come.

EMERGENCY RESPONSES

During the past year the Watch Hill Fire Department responded to a total of 181 alarms. These calls included the following:

Fortunately, the structure fires which occurred within the District were quickly extinguished with minimal damage.

The majority of the fire alarm activations, both commercial and residential, were due to malfunctions of the fire alarm systems. The remaining causes of the false alarms were investigated and attributed to burned food on the stove and contractors failing to take the proper precautions before working near detectors.

As in recent years, residential and commercial alarm activations represent a majority of the calls to which our members respond. Several of these calls are caused by workers and contractors who have not taken the recommended action of covering a smoke detector while performing work. Please remind these workers to

take all necessary precautions while performing work at your property. The majority of our activations are caused by system malfunctions. Please make sure that your fire alarm system is properly inspected and maintained in order to avoid nuisance alarms.

Please bear in mind that such alarms often occur during business hours. In fact, approximately 50% of our calls occur during the period between 8 AM to 4 PM and approximately 70% of these calls occur during the period between Monday and Friday. This results in a loss of wages for our volunteers as well as decreased business production for those employers who allow their workers to respond from work.

In addition, the first arriving units often find these residences unoccupied and are unable to easily gain access. Full access is necessary to accurately determine and mitigate the cause of many of these alarms. We have found it helpful to have a caretaker or responsible party available to respond and assist at all hours. Please contact the fire department so you may provide the necessary contact information in the event of an emergency.

FIRE DEPARTMENT RESPONSE

One of the most important factors while responding to a potential emergency is a quick and efficient response time. A quick response may potentially be the difference between a major property loss or a loss of life.

As indicated in previous reports to the District, improperly marked houses and overgrowth of shrubbery often delay and hamper an effective response by the Fire Department. We ask you to again take the time to assess these factors at your own properties and make the necessary accommodations and modifications if necessary. Please feel free to contact the station if you require additional assistance in identifying and resolving these issues.

TENT APPLICATION AND PLAN REVIEW PROCESS

The Watch Hill Fire Department in cooperation with the Board of Engineers has recently updated the application process and fee structure for tents as well as plan review for both new and existing structures. These fees are in accordance with all applicable statutes and in most cases mirror the recommended fee structure utilized at the state level. All necessary forms as well as an updated fee schedule may be found in the Public Information section of the Department's web site at <u>www.watchhillfire.com</u>. SCBA REPLACEMENT

The department's inventory of Self-Contained Breathing Apparatus (SCBA) have reached their NFPA mandated life-expectancy of 20-years and are in need of replacement. The Board of Engineers has requested an the Finance Committee has appropriated the required funds for the purchase of twenty (20) Scott Brand SCBA which most closely match our current equipment. Because we have purchased spare SCBA bottles on a rotating basis over previous cycles we were able to reduce the overall cost of this project. Additionally because these units most closely match our existing equipment we will be able to easily train our members for their use in a timely and effective manner.

IMPORTANT DATES

The Annual Karl E. Kenyon Smokey Bear Parade is scheduled for Thursday July 21st and is expected to make its way through the Bay Street area at approximately 7 PM. The Watch Hill Fire Department Annual Fire Prevention Open House is scheduled for Wednesday August 3rd. Please check the Fire Department website for important updates on these events.
